- ☞ The research paper is to be typed in font Times New Roman with font size 12 and line spacing 1.5, headings to be typed in font size 14 Bold, and footnotes in font size 10.
- ☞ The abstract should be 300 words with a minimum of five (5) keywords and must be accompanied by a cover page consisting of the author's/co-authors' details.
- ☞ All the submissions are to be sent to email ID: cenexcrime@ifheindia.org
- ☞ All the accepted full research papers submitted before the deadline will be published in a book form with an ISBN number. The presentation of an accepted research paper is mandatory for the purpose of publication.




