Examination Centres

3. The examination will be conducted at 13 Centres across India. The details of the centre are as under:

Examination Centre Allocation

4. The centre allocation list is attached at **Annexure I**. The centres address will be uploaded on University website in due course of time. The centre has been allocated to applicants as per their registered home state details in the application form. While allocating the centre, applicants home state and geographical proximity to the examination centre has been taken into consideration.

Entry to Examination Hall

5. The applicants are requested to carry print out of their Application form and personal Government identity proof (Aadhar card/PAN card/Driving Licence/Passport/Voter ID card) on the day of the entrance examination. The applicants will be permitted to enter the examination hall after verification of their identity details as mentioned in the application form with their identity proof. Applicants are requested to report to examination Centres at least one and half hour before the commencement of examination. The entry in the examination hall will be closed 30 minutes before the commencement of entrance examination.

Conduct of Examination

6. Applicants are not permitted to carry any personal belonging inside the examination hall that include laptops, calculators, cell phones, cameras, beepers, digital diaries, bags, notebook or pieces of papers. The paper for the rough work will be provided at the test hall and must be returned to the invigilator after the computer based test (CBT). The computer based test will be conducted at respective examination centres and each student will be provided with a computer system. The detailed instructions regarding the conduct of examination will be given prior



to start of examination. Any applicants found involved in using any type of unfair means during the examination will be expelled from the examination hall.

COVID-19 Guidelines

7. The applicants are requested to follow COVID-19 safety protocols during the conduct of examination. The applicants need to wear the face mask and follow social distancing norms. Any violations of COVID-19 safety protocol will make them liable for debarment from the examination. The important instructions for candidates on COVID-19 are as under:-

- (a) Candidates must maintain social distancing starting from point of entry in the exam venue till his/her exit from the exam venue.
- (b) Candidate must bring their own Mask, Gloves, personal hand sanitizer (50ml), transparent water Bottle, a simple pen and the examination related documents (Print out of the application form, ID Card etc.). No other items will be permitted inside exam venue.
- (c) Candidates showing COVID-19, symptoms will not be allowed entry into the examination venue.
- (d) Entry of Candidates will be given as per the time slot mentioned in the instructions to maintain Social Distancing at the Centre.
- (e) Temperature of the candidates will be checked at the entry to the examination venue via a Thermo Gun. Only those candidates will be allowed inside the exam venue whose temperature is within the acceptability limits as approved by competent authorities.
- (f) Mapping of 'Candidate Application Sequence Number and the Lab Number' will not be displayed outside the exam venue, but the same will be provided to the candidates individually at the time of entry of the candidate to the exam venue and post their application form and ID verification.
- (g) Candidates need to follow directions given by representatives and need to stand in the circles drawn at the entry points.
- (h) At registration desk, the candidate will be directed to sanitize his/her hands using provided sanitizer. Photograph will be captured during the registration process.
- (i) Candidates will be under CCTV coverage throughout the exam procedure.
- (j) Candidate is required to report at the examination venue strictly as per the time slot mentioned in the instructions. It is expected that candidate strictly adheres to this time slot – as entry into the test centre will be provided based upon the individual's time slot only.
- (k) The student needs to carry self-declaration form in the format shown below and submit the same at the entry of the examination hall.
